

Job Title: Research & Evaluation Survey Methodology Intern

We are looking for detail-oriented and organized team members who excel in fast-paced nonprofit environments, are interested in working to promote community health through inquiry, innovation and impact and in joining a well-respected, high-impact organization with a rich history of community service.

To inform efforts at The Center and among our many organizational partners, our Research and Evaluation Department is creating a community panel. This panel will serve as a platform for social justice efforts, especially to unite community voices and connect public opinion and perspectives to decision makers and policy advocates. The Survey Methodology Intern will provide collaborate to create surveys critical to the success of these paneling efforts.

Overview:

This opportunity is ideal for undergraduate and masters level students who are majoring in public health, psychology, education, statistics, or social work with a focus on research and evaluation in underserved communities. The intern should be prepared to work in a fast-paced, team environment, and will finish the internship having gained broad experience in various aspects research and evaluation, and having helped to shape Center's research, evaluation, and community panel efforts.

Responsibilities

- Collaborate with Research and Evaluation team to explore available and validated survey tools
- Design and test surveys related to topics including social justice, self-perceived mental health, self-perceived physical health, self-perceived oral health, community health, wellness, connectedness, community trust, safety, transportation access, healthcare access, etc.
- Collaborate on the creation of our community panel to optimize survey response rates and targeted survey distribution

Requirements/Qualifications

- Fundamental understanding of social justice issues, particularity as related to Metro Denver communities
- Demonstrated commitment to Metro Denver communities of color
- Organized, efficient, proficient at multi-tasking
- Able to grasp all moving parts of a project or event
- Excellent communication, negotiation, and mediation skills
- Team player, able to receive direction and instruction
- Works well under pressure
- Self-starter, proactive, and takes initiative
